The terms and conditions of the contract shall be:-

- The company will utilize two sealed containers of 32 ft length each and rate per container should be Rs. 1.25 lacs F.O.R Govt. Polytechnic College Jammu, the receiving destination. The rate is inclusive of loading and unloading charges, enroute taxes, tolls, octrai etc.
- The transport company will lift above said machines from strong rooms of District Administration Concerned i.e District Vaishali and District Patna.
- The movement of transport will be under security cover provided by the Government. The
 containers should move through National Highways from loading destinations in Bihar state to
 F. O. R destination i.e Jammu
- The enroute haltage points should be decided by the escort team leading the containers, keeping in view the security matters.
- It will be the sole responsibility of the transport company to ensure safe delivery of machines in terms of quantity at the receiving point.
- 40% of freight charges shall be paid in advance and rest 60% be paid after safe arrival/unloading of machines in strong rooms of Govt. Polytechnic College Jammu.
